Chapter 1 General Provisions

Article 1 The name of this university is Kyoto University of Advanced Science (hereinafter referred to as "KUAS"). The name of the university in English is Kyoto University of Advanced Science.

Article 1-2 The aim of KUAS, based on the Basic Act on Education and the School Education Act and the founding principles of the Nagamori Gakuen Educational Foundation, shall be to nurture top-notch professionals who can identify and solve the problems of the future. Furthermore, KUAS will aim to impart a broad foundational knowledge to all of its students through comprehensive teaching and indepth research of the arts and sciences.

Article 1-3 The educational objectives of each faculty and department at KUAS are shown in Appended Table 1.

Chapter 1-2 Self-inspection and Self-evaluation

Article 1-4 KUAS shall conduct self-inspections and self-evaluations of the status of its educational and research activities, etc., to improve educational standards and achieve the objectives outlined in Article 1-2.

2 KUAS shall establish a committee for self-inspection and self-evaluation to carry out the inspections and evaluations outlined in the preceding paragraph.

Article 4 The term of study shall be 4 years. However, the enrollment period for undergraduate students cannot exceed 8 years.

- 2 Notwithstanding the provision of the preceding paragraph, it may be sufficient for those who have earned the prescribed credits stipulated in Article 15 with excellent grades to be enrolled for three years or more.
- 3 In the case where a person who has earned a certain number of credits at KUAS as a non-student is admitted to KUAS, if the President of KUAS recognizes that the person has completed a part of the educational program at KUAS by earning such credits, the President of KUAS shall determine the period during which the person is recognized as having completed the educational program, taking into consideration the number of credits earned and other matters, and the total credits earned shall be added to the period of study stipulated in paragraph 1. The period of study may be counted toward the period of study stipulated in Paragraph 1.

Chapter 3 Academic Year, Semester Dates, and Holidays

Article 5 The academic year begins on April 1 and ends on March 31 of the following year.

Article 6 The academic year shall be divided into the following two semesters.

(1) Spring Semester (from April 1 to September 15)

(2) Fall Semester (from September 16 to March 31 of the following year)
Article 7 Holidays shall be as follows.

- (1) Saturdays and Sundays
- (2) Days stipulated as holidays by the "Act on National Holidays"
- (3) Deleted
- (4) Deleted
- (5) Summer Vacation: As prescribed separately in the KUAS academic calendar
- (6) Winter Vacation: As prescribed separately in the KUAS academic calendar
- (7) Spring Vacation: As prescribed separately in the KUAS academic calendar
- 2 Other days deemed necessary by the President may be designated as special holidays.
- 3 Classes may be held on holidays when the President deems it necessary.

Chapter 4 Courses and Course Registration

Article 8 Courses, credits, and how to register for courses at KUAS shall be as shown in Appended Table 1-2.

2 Those who have earned the prescribed credits with excellent grades may be allowed to register for courses regardless of the course registration limit specified in Appendix Table 1-2.

Article 8-2 The qualifications that can be acquired at KUAS are as follows.

- Article 8-5 Establish a food hygiene course in the Faculty of Bio-Environmental Science at KUAS.
- Article 9 Classes at KUAS shall be conducted through lectures, seminars, experiments, practical training, or skills practice, or a combination of these.
- 2 As separately determined by the Minister of Education, Culture, Sports, Science and Technology, the lessons referred to in the preceding paragraph may be taken at places other than classrooms, etc., where such lessons are taught, by making advanced use of a variety of media.
- 3 The classes mentioned in paragraph (1) above may be taken in a foreign country. The same shall apply to the case of having students take classes in places other than classrooms where said classes are provided by making innovative use of various media as prescribed in the preceding paragraph.
- Article 10 The number of credits will be calculated based on the number of classes per unit, which will be approximately 15 to 45 hours as determined by the university.
- 2 The number of credits for graduation theses, graduation research, graduation projects, and similar courses shall be determined in consideration of the study required for these courses.
- Article 10-2 In principle, classes, including examinations, shall be held for 35 weeks per year.
- Article 11 The distribution of courses throughout the year shall be provided separately.
- Article 12 Students must notify KUAS of the courses they intend to take by the prescribed date.

Chapter 5 Granting of Credits, Graduation Accreditation, and Degree Certificates

- Article 13 Students who have taken courses shall be evaluated on the basis of the results of their studies and awarded credits through examinations and other appropriate methods determined by the university.
- 2 The regulations concerning examinations shall be provided separately.
- 3 The maximum grade for a course shall be 100 points, and a grade of 60 points or

fewer shall be a failing grade. For students admitted during the 2018 academic year or earlier, grading shall be as follows.

Article 14 KUAS may allow students to take courses at other universities or junior colleges that it deems appropriate, if it is deemed educationally beneficial.

- 2 The credits acquired in accordance with the preceding paragraph may be approved as graduation requirements up to 60 credits after the approval of the Faculty Council.
- Article 14-2 When deemed educationally beneficial, studies completed by students at junior colleges or colleges of technology that are deemed appropriate by KUAS, and other studies as specified separately by the Minister of Education, Culture, Sports, Science and Technology, may be regarded as coursework at KUAS and credited toward graduation requirements after approval by the Faculty Council.
- (2) The number of credits that can be granted in accordance with Paragraph 1 shall not exceed 60 credits, including the number of credits deemed to have been acquired at KUAS in accordance with Paragraph 2 of the preceding article.
- Article 14-3 When deemed educationally beneficial, credits earned from courses taken at universities or junior colleges prior to enrollment in KUAS may, with the approval of the Faculty Council, be deemed to have been earned through coursework taken

after enrollment in KUAS.

Faculty of

- 2 When deemed educationally beneficial, the study stipulated in Paragraph 1 of the preceding article, conducted prior to the student's enrollment at KUAS, may be regarded as completion of coursework at KUAS, and credits may be granted after discussion by the Faculty Council.
- 3 The number of credits that may be deemed to have been acquired or granted in accordance with the preceding two paragraphs shall not exceed 60 credits in total for credits other than those acquired at KUAS, except in the case of transfer students, etc.
- Article 15 In addition to earning the prescribed credits, a diploma shall be awarded as determined by the university.
- 2 Graduates of KUAS shall be conferred a bachelor's degree and shall be assigned the name of the following major field of study according to the major in which they studied.

Chapter 6 Admission, Withdrawal, Leave of Absence, Study Abroad, Transfer,

Transfer Faculty, Transfer Department, and Transfer of Institution

Article 16 Enrollment period shall be at the beginning of each semester.

Article 17 Those who are eligible for admission to KUAS shall be those who meet one of the following conditions

- (1) Those who have graduated from high school
- (2) Those who have completed 12 years of school education through a regular course (including those who have completed school education through a course other than a regular course that is equivalent thereto).
- (3) Those who have completed 12 years of school education in a foreign country or those who have been designated by the Minister of Education, Culture, Sports, Science and Technology as equivalent thereto.
- (4) Those who have completed a course at an overseas educational institution that has been accredited by the Minister of Education, Culture, Sports, Science and Technology as having a course equivalent to that of a high school course.
- (5) Those who have been designated by the Minister of Education, Culture, Sports, Science and Technology
- (6) Those who have passed the University Entrance Qualification Examination administered by the Minister of Education, Culture, Sports, Science and Technology in accordance with the University Entrance Qualification Examination Regulations.
- (7) Those who have reached an appropriate age and be recognized by KUAS as having academic ability equivalent to or greater than that of a high school graduate.

Article 18 Applicants applying for admission to KUAS must follow the prescribed

- procedures.
- 2 The procedures for admission shall be prescribed separately.
- Article 19 Students seeking permission to take a leave of absence or withdraw from KUAS due to illness or other reasons must submit a request jointly signed by their guarantor.
- 2 The period of leave of absence may not exceed two consecutive years. However, in case of special reasons, it may be extended for up to one year.
- 3 Time spent on a leave of absence shall not be counted towards the number of years of enrollment as prescribed in Article 4.
- 4 The total period of a leave of absence shall not exceed four years.
- 5 When a student taking a leave of absence intends to re-enroll, they must submit a re-enrollment application and obtain permission.
- Article 19-2 Students who have been approved by KUAS to study abroad shall be regarded as "studying abroad", and shall not be treated as students "taking a leave of absence".
- 2 Study abroad shall be included in the years of study as stipulated in Article 4.
- Article 20 If a student who has left the school at his/her requests requests to be readmitted within two years, he/she may be permitted to do so.
- Article 21 When a student who falls under one of the following categories applies for transfer admission, he/she may be admitted to the appropriate year after selection only when there is a vacancy.
 - (1) Those who have graduated from or withdrawn from a university.
 - (2) Those who graduated from or withdrew from a junior college or college of technology.
 - (3) Those who have completed a special training school
- 2 No student may apply for admission or transfer to another university without permission from the president.
- 3 When a KUAS student requests a transfer, the student may be allowed to transfer to the appropriate year after selection only if there is a vacancy in the department to which the student is transferring.
- 4 When a KUAS student requests a transfer, the student may be permitted to transfer

to the appropriate year after selection only if there is a vacancy at the transfer institution.

Chapter 7 School Fees

- Article 22 Those who apply for admission to KUAS must pay the entrance examination fee.
- 2 The amount of the entrance examination fee shall be determined separately.
- Article 23 Those who are admitted to KUAS must pay the admission fee.
- Article 24 Students must pay tuition, facility and equipment fees, laboratory fees, and other school fees as stipulated.
- Article 25 Non-degree students must pay the registration fee and course fee, undergraduate course auditors must pay the auditing fee, sponsored students must pay the education fee, and research students must pay the registration fee and research fee.
- 2 Non-degree students from high schools affiliated with KUAS who take courses as Non-degree students are exempted from the registration and course fees stipulated in the preceding paragraph.
- Article 26 The amount of the admission fee, tuition and other school fees shall be as shown in Appendix 2.
- Article 26-2 The collection of school fees shall be determined separately.
- Article 27 Once accepted, school fees are not refundable for any reason.
- Article 27-2 Students will be exempt from the payment of school fees for the duration of their leave of absence. During the period of absence, the enrollment fee must be paid each spring and fall semester. In addition, students who have paid school fees during the said period shall be exempted from paying the enrollment fee.
- Article 28 Those who fail to pay tuition and other school fees shall be dismissed.
- 2 When a student who has been dismissed under the preceding paragraph requests reinstatement, permission may be granted after screening.
 - Chapter 8 Staff organization and faculty meetings, etc.
- Article 29 KUAS shall have educational, administrative and other staff members.
- Article 30 Educational staff shall be professors, associate professors, junior associate

professors, assistant professors, and research assistants.

Article 31 KUAS shall have a President and Deans.

- 2 KUAS may have a vice president.
- 3 Each faculty may have a vice dean.
- 4 Each department may have a department head.
- 5 The president shall oversee academic affairs and supervise the staff of the university.
- 6 The Vice President shall assist the President and oversee academic affairs as ordered.
- 7 Deans shall oversee the academic affairs related to the faculty concerned.
- 8 The Vice Dean shall assist the Dean in his/her duties.
- 9 The Department Head organizes and coordinates the academic affairs of the department concerned under the order of the dean.
- Article 32 KUAS shall establish the University Council as an organization to assist the President by deliberating important matters concerning the organization, administration, and education and research activities of KUAS, expressing opinions to the President, and making decisions.
- 2 The University Council shall consist of the President, Vice Presidents, Deans of each department and graduate school, the University Bureau Chief Director and the Vice Chief Director of the University Bureau.
- 3 When the President deems it necessary, he/she may request the attendance of persons other than those mentioned in the preceding paragraph to hear their opinions or to have them make reports or explanations.
- Article 32-2 The authority and operation of the University Council shall be determined separately.
- Article 33 The faculties of KUAS shall have a Faculty Council as an organization that extends its opinions when the President makes decisions on important matters concerning education and research, deliberates on matters concerning education and research under the control of the President and Deans, and may express its opinions at the request of the President and Deans.
- 2 The Faculty Council shall consist of the deans, vice deans, department heads, and other professors.

- 3 Associate professors and other staff members may be added when deemed necessary by the Dean.
- Article 34 Matters concerning the role and operation of the Faculty Council shall be prescribed separately.
- Article 34-2 KUAS shall establish a department meeting as an organization that reports and communicates the deliberations, consultations, and decisions made at the regular, extraordinary, performance review, and other faculty meetings of the department, and coordinates and facilitates the smooth operation of the department concerned.
- 2 The department meeting shall consist of professors, associate professors, lecturers, assistant professors, and assistant professors in addition to the department chairperson.
 - Chapter 9 Non-degree students, Auditing students, Sponsored students,
 Research students
- Article 34-3 Those who apply to take courses may be approved as Non-degree students after selection.
- 2 When there is a student from another university who wishes to take courses at KUAS, KUAS may permit the student to enroll as Non-degree students from the other university based on discussions with the other university.
- 3 Non-degree students from high schools or colleges of technology who wish to take classes at KUAS may be accepted as non-degree students after screening.
- 4 Non-degree students may receive credit.
- Article 35 Students who have requested to audit a specific class may be permitted to do so after screening.
- 2 Deleted
- 3 Auditing students shall not receive academic credits.
- Article 36 Deleted
- Article 37 If a public organization or other institution sponsors a student to study a particular course at KUAS, the student may be accepted as a sponsored student after screening.

2 No credit will be given to sponsored students.

Article 37-2 Students who have applied to study a specific subject at KUAS may be accepted as research students upon selection.

2 Research students shall not receive academic credits.

Article 38 Deleted

Article 39 Non-degree students, auditing students, sponsored students, and research students must abide by the university regulations and other rules. However, the provisions of Articles 4 and 15 shall not apply mutatis mutandis.

Chapter 10 Awards and Punishments

Article 40 Awards may be given to students who excel in both conduct and academics and who set a good example for others.

Article 41 If a student violates the University regulations or other rules, or commits any other act contrary to the student's true nature, the President shall discipline the student after hearing the opinions of the Faculty Council.

2 Disciplinary actions shall include admonishment, suspension, and expulsion.

3 Matters concerning disciplinary actions shall be set forth in the "Regulations Concerning Student Discipline"

Article 42 If Non-degree students, auditing students, sponsored students, or research students violate the University regulations or other rules, the President may, after hearing the opinions of the Faculty Council, revoke their permission.

Chapter 11 Library

Article 43 A library shall be established in KUAS.

2 Regulations concerning the library shall be prescribed separately.

Chapter 12 Psychoeducational Counseling Office

Article 44 KUAS shall establish a Psychoeducational Counseling Office.

2 Regulations concerning the Psychoeducational Counseling Office shall be prescribed separately.

Chapter 13 Student Dormitories

Article 45 KUAS shall establish student dormitories.

2 Regulations concerning student dormitories shall be determined separately.

Chapter 14 Extension Lectures

Article 46 KUAS may offer public lectures from time to time.

Chapter 15 Supplementary Rules

Article 47 In addition to the provisions of these school regulations, matters necessary for the enforcement of the school regulations shall be determined separately.

Article 48 In amending or repealing these regulations, the President shall hear the opinions of the councils for each faculty and the university council.
